REMINDER FOR MARINA TENANTS Re: Independent Contractors

"Companies and/or workers hired by Owner to accomplish tasks aboard a vessel are required to sign-in with the marina office and execute a Premises Access Agreement. They are also required to carry liability insurance with a minimum limit of \$1 million and have Shelter Cove designated as additional insured, have a copy of their business license on file at the marina and provide worker compensation insurance for their employees." **DO NOT** permit workers on your boat if they have not checked into the office!

has claimed over the past year!

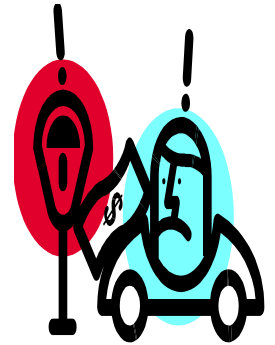


Please be sure we have your current phone number on file in the event of an emergency... This past month, we have had several instances
